RULES AND REGULATIONS

RIGHTS: A valid Passport membership, Season Pass, Multi-week, Mini Pass or Daily Pass and similar, (hereafter referred to as A Pass) gives an individual the use of our facilities during regularly scheduled times. The Pass must be worn at all times while visiting Willamette Pass Ski Area in order to gain use. A Pass is a convenience item. It allows you to partake in our offerings. A Pass allows for the use of parking lots, uphill transportation (lifts), skiing at Willamette Pass Ski Area, usage of the Lodge, and participation in our other offerings. Many services and products within our facility can be purchased in addition to a Pass. A Pass does not relieve you of these fees if you choose to use them. These include items such as, Restaurant, Bar, Retail Shop, Rental Shop, Tubing, etc.

RESPONSIBILITIES: You are a guest of our facility. We will serve you to the best of our abilities, likewise your courtesy will be expected in return. There will be a strict enforcement of all safety regulations. Skiers/snowboarder's responsibility code, including reckless and excessive speed, skiing/snowboarding outside the ski area boundary, disregard of ski slope etiquette, including inappropriate and/or offensive language. It is the pass holder's responsibility to learn what these rules are. Ignorance of the regulations will not be an excuse. The purchaser or user of this pass, in accordance with Oregon's Skiing Activities Act ORS 30.970 to 30.990, understands that skiing/snowboarding is a hazardous sport and accepts and assumes the inherent risks thereof including, but not limited to; changing weather conditions, variations or steepness in terrain, snow or ice conditions, surface or subsurface conditions, bare spots, creeks and gullies, forest growth, rocks, stumps, lift towers and other structures and their components, collisions with other skiers and a skier's failure to ski within the skiers own ability.

CONSEQUENCES: If any behavior is in violation of our goal to provide a safe and pleasant skiing/snowboarding experience for all, the guest will be confronted and one or more of the following events may occur:

1. A verbal warning will be given
 2. Your Pass will be seized for the day AND a verbal warning given.
 3. Willamette Pass reserves the right to revoke any Pass for violation of our rules and regulations.
- Willamette Pass Resort reserves the right to refuse service to anyone based on any of the above items.

WARNING TO SKIERS, SNOWBOARDERS, LIFT PASSENGERS AND AGREEMENT OF RELEASE AND INDEMNITY PLEASE READ CAREFULLY:

As a condition of use of the ski area facilities, the USER assumes all risk of personal injury, death, or property loss resulting from any cause whatsoever. Including, but not limited to; the inherent risks of skiing and snowboarding, the use of lifts, collision with natural or man made objects, other skiers or snowboarders, travel within or beyond the ski boundaries, or negligence or breach of contract on the part of Willamette Pass Resort and its employees and agents.

USER AGREES TO RELEASE AND INDEMNIFY WILLAMETTE PASS AND ITS EMPLOYEES AND AGENTS FROM ANY AND ALL CLAIMS AND LIABILITIES (INCLUDING CLAIMS BASED UPON NEGLIGENCE) ARISING OUT OF OR IN CONNECTION WITH THE USE OF THE SKI AREA FACILITIES.
